How to Apply for Using Smart Identity Card as  
Identity Card Allowed for Library Purposes

**十八歲或以上人士**

- 填妥申請表格；
- 將申請表格連同智能身份證及住址證明文件 (例如電費單、水費單等) 交回申請處。(如你已持有香港公共圖書館、前市政局公共圖書館或前區域市政局公共圖書館簽發的圖書證，則無需出示住址證明文件。)

**十八歲以下人士**

- 填妥申請表格；
- 請家長(父親或母親)或監護人在申請表格上的「保證書」簽署；
- 將申請表格連同申請人的智能身份證、家長或監護人的身份證副本及住址證明文件交回申請處。

**外借數目限制**

辦妥申請手續的人士可外借最多六項圖書館資料，為期十四日。

**遺失圖書館適用身份證**

圖書館適用身份證持有人如遺失身份證，應立即以書面向香港公共圖書館報失。

**更改地址**

圖書館適用身份證持有人的地址如有更改，請以書面通知任何一間香港公共圖書館。

**Persons aged 18 or above**

- Complete an application form;
- Present the application form together with your Smart Identity Card and proof of your home address (e.g. electricity bill, water account etc.) at the registration counter. (If you hold a library card issued by the Hong Kong Public Libraries, Ex-Urban Council Public Libraries or Ex-Regional Council Public Libraries, you are not required to produce proof of your home address.)

**Persons under the age of 18**

- Complete an application form;
- Have the guarantee section of the form signed by your parent (father or mother) or guardian;
- Present the application form together with your Smart Identity Card, photocopy of your parent's or guardian's identity card and proof of home address at the registration counter.

**Borrowing limit**

Any person who has completed the application procedure can borrow up to a maximum of 6 items of library materials at one time for a period of 14 days.

**Loss of Identity Card Allowed for Library Purposes**

Holders of identity card allowed for library purposes should report loss of their cards at once in writing to the Hong Kong Public Libraries.

**Change of Address**

Holders of identity card allowed for library purposes should notify their change of address in writing to any Hong Kong Public Libraries.
