This paper investigates the situation of assistive education technologies use for children with disabilities in low and middle-income countries. The results find that the usage is rather limited and positively related to children education outcome. The paper also highlights the main causes are unawareness on disabled children needs, profitability, inequalities, limitation on infrastructure, and higher participation of individual schools and NGOs than the governments.
