

Introduction

引言

OECD iLibrary is the online library of the Organisation for Economic Co-operation and Development (OECD). It contains all books and papers published by the OECD since 1998 and a vast collection of statistical data dated back to the 1960's. The database covers a wide range of subjects, including agriculture and food, economics, education, environment, social issues, science and technology, taxation, etc.

In recent decades, many countries have experienced rapid population ageing due to falling birth rate and rising life expectancy. The trend has brought significant implications urging governments to implement reforms in various aspects, such as employment policies, health care systems, pension systems, and financial education. OECD iLibrary contains research and studies on these topics across OECD and non-OECD countries. This resources list provides a selection of related books, papers and statistics available at OECD iLibrary for reference of users.

OECD iLibrary 是經濟合作及發展組織(經合組織)的線上圖書館,提供經合組織自 1998 年起出版的所有書籍及論文,以及大量可追溯至二十世紀六十年代的統計數據。資料庫主題廣泛,涵蓋農業與食品、經濟、教育、環境、社會問題、科學技術、稅務等。

近數十年,由於出生率下降,加上人愈來愈長壽,許多國家都面對人口急速高齡化的問題。這項趨勢影響重大,促使各國政府在就業政策、醫療制度、養老金制度和理財教育等方面推行改革。OECD iLibrary 提供成員國與非成員國就該等課題所作的調查研究。本資源選介從 OECD iLibrary 中精選了相關的書籍、論文及統計資料,以供使用者參考。

III. Statistics

OECD iLibrary provides statistical information that includes databases and indicators on various topics. The interactive databases and indicators enable users to customise the selection and layout of data and support export of data in different file formats (e.g. Excel, CSV, PC-Axis, etc).

OECD Employment and Labour Market Statistics

The database includes labour market statistics and indicators from 1960 concerning information about part-time and short-time workers, hours worked, unemployment duration, employment protection legislation, minimum wages, labour market programmes for OECD countries and non-member economies.

OECD Health Statistics

The database offers comparable statistics on health and health systems across OECD countries and selected non-OECD countries. It provides data dated back to 1960 on health care financing, health care resources, social protection, the pharmaceutical market, and demographic and economic references.

Launched in 2002, the Global Pension Statistics' project aims to provide a valuable device for measuring and monitoring the pension industry, and to permit inter-country comparisons of current statistics and indicators on key aspects of retirement systems across OECD and non-OECD countries.
